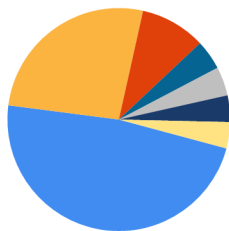

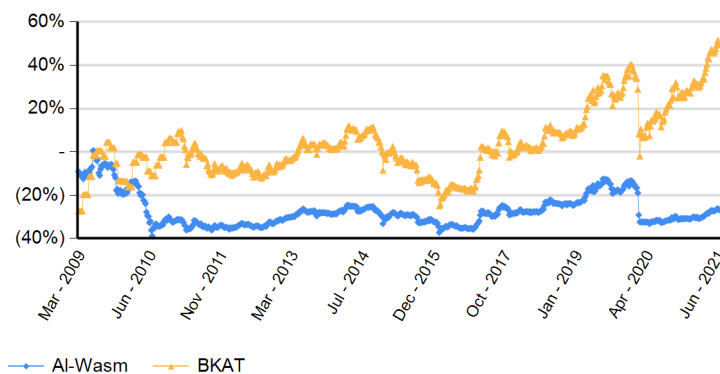
Sector Distribution
