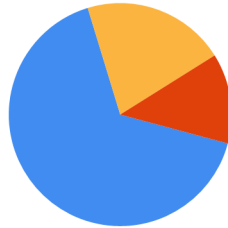

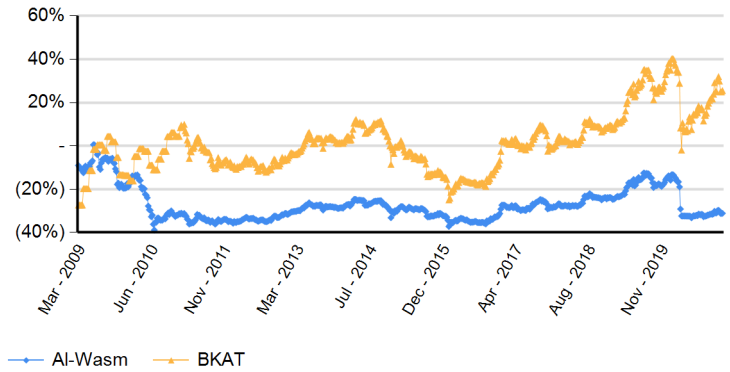
### Sector Distribution
